FROM NEW YORK CITY

Take the Lincoln Tunnel (LT) to New Jersey. Exit the LT and follow signs to New Jersey Turnpike/I95 (NJT).

Take the NJT to exit 15W (Newark/Kearny/Route 280). Exit and follow signs to Route 280WEST. Follow route 280WEST to Exit 8B (Prospect Ave/Cedar Grove)

Exit onto Prospect Ave and proceed to the 2<sup>nd</sup> light. This major intersection is Eagle Rock Avenue. Move to the left lane and turn left onto Eagle Rock Ave. Follow Eagle Rock Ave to the first light – Forest Road. Turn right onto Forest Road. Very Shortly – turn left onto McManus Court than turn left onto Waldeck Court.

20 Waldeck is on the left side as you make the turn in the middle of Waldeck Court.

FROM SOUTH JERSEY VIA GARDEN STATE PARKWAY

Take the Garden State Parkway (GSP) North to Exit 145 (East Orange/Newark/I-280). Follow route 280WEST to Exit 8B (Prospect Ave/Cedar Grove).

Exit onto Prospect Ave and proceed to the 2<sup>nd</sup> light. This major intersection is Eagle Rock Avenue. Move to the left lane and turn left onto Eagle Rock Ave. Follow Eagle Rock Ave to the first light – Forest Road. Turn right onto Forest Road. Very Shortly – turn left onto McManus Court than turn left onto Waldeck Court.

20 Waldeck is on the left side as you make the turn in the middle of Waldeck Court.

FROM SOUTH JERSEY VIA NEW JERSEY TURNPIKE

Take the New Jersey Turnpike/I95 NORTH (NJT) to Garden State Parkway NORTH (GSP) Exit 11 (Woodbridge). Follow GSP to Exit 145 (East Orange/Newark/I-280). Follow route 280WEST to Exit 8B (Prospect Ave/Cedar Grove). Exit onto Prospect Ave and proceed to the 2<sup>nd</sup> light. This major intersection is Eagle Rock Avenue. Move to the left lane and turn left onto Eagle Rock Ave. Follow Eagle Rock Ave to the first light – Forest Road. Turn right onto Forest Road. Very Shortly – turn left onto McManus Court than turn left onto Waldeck Court.

20 Waldeck is on the left side as you make the turn in the middle of Waldeck Court.

FROM NORTH JERSEY VIA GARDEN STATE PARKWAY

Take the Garden State Parkway (GSP) South to Exit 145 (East Orange/Newark/I-280). Take 280 WEST to Exit 8B (Prospect Ave/Cedar Grove).

Exit onto Prospect Ave and proceed to the 2<sup>nd</sup> light. This major intersection is Eagle Rock Avenue. Move to the left lane and turn left onto Eagle Rock Ave. Follow Eagle Rock Ave to the first light – Forest Road. Turn right onto Forest Road. Very Shortly – turn left onto McManus Court than turn left onto Waldeck Court.

20 Waldeck is on the left side as you make the turn in the middle of Waldeck Court.

FROM NORTH JERSEY VIA NEW JERSEY TURNPIKE

Take the New Jersey Turnpike/I95 South (NJT) to exit 15W (Newark/Kearny/Route 280). Exit and follow signs to Route 280WEST. Follow route 280WEST to Exit 8B (Prospect Ave/Cedar Grove)

Exit onto Prospect Ave and proceed to the 2<sup>nd</sup> light. This major intersection is Eagle Rock Avenue. Move to the left lane and turn left onto Eagle Rock Ave. Follow Eagle Rock Ave to the first light – Forest Road. Turn right onto Forest Road. Very Shortly – turn left onto McManus Court than turn left onto Waldeck Court.
